A Report on the workshop conducted at Institute for Plasma Research, Gandhinagar

1. INTRODUCTION:

The Institute for Plasma Research (IPR), Gandhinagar has been developing technologies for societal and industrial applications apart from its ongoing fundamental research activities on plasma science and technology. It has therefore been patenting technologies developed by IPR regularly. However, with the current emphasis of making science useful to the society, an upsurge of society & industry specific technology development has taken place. Since technology commercialization and transfer is involved, it is necessary that such technologies and knowhow is secured through patents. The awareness of such intellectual property rights is therefore important to be generated amongst the inventors/researchers.

With this objective, the Department of Atomic Energy (DAE) – Patent cell in association with IPR had been working on conducting a workshop on intellectual property rights at IPR, Gandhinagar. The Administrative Training Institute (ATI), DAE had been kind enough to grant the financial sanction for conducting the above workshop at IPR Gandhinagar on 19th Nov, 2018. Marking the start of the programme, Dr. Nirav Jamnapara, Head – Projects & Technology Transfer Section of IPR, welcomed the participants and the speakers to the workshop on intellectual property rights sponsored by ATI-DAE and conveyed the objective of the workshop in IPR. Subsequently, Shri A. Varadharajulu, Chairman – Technology Transfer and Intellectual Property (TTIP) Committee of IPR gave the inaugural talk. His talk conveyed the present status of patenting activities in IPR and how IPR was growing in terms of the technologies developed for societal and industrial applications and the need for securing such intellectual property. He appreciated DAE's support in conducting such a workshop which was very much needed.



Mrs. Anuradha Maheshwari introduced the participants with the types of intellectual property (e.g. Patents, Copyright, Trademark, Geographical Indications, Semiconductor layout design, Trade Secrets and Design) and briefly explained about each of them with examples.

Subsequently, Mrs. Maheshwari explained about the patenting process in detail, International patents (PCT) and the journey from a patent to technology. Various examples on how patents have been able to change the financial condition of various companies was showcased. Overall, the transition of an idea to a patented commercializable technology was explained nicely.

The talk of Mrs. Maheshwari was followed by the talk on 'Technology Transfer Mechanism in BARC' by Dr. Nutan Khalap. Dr. Khalap explained in detail how BARC interacts with Industries and how BARC offers various technologies on transfer basis to industries. Various videos on technologies developed by BARC were shown emphasizing the reach of such technologies to end users.

The final talk was by Shri Dani Rajiah, Member-Secretary DAE-IPR Cell and was focused on 'DAE experience in patenting'. Shri Dani explained the statistics of patenting being done by DAE and the procedure of review and processing the patent applications. The magnitude of patents filed by DAE was also shown with specific statistics on patenting by IPR Gandhinagar. This helped the participants understand the patent application processing through DAE-IPR cell. Each talk was followed by question and answer session so as to clear possible doubts of the participants.









Overall feedback on Parameters




Feedback on talks
















संकाय का स्तर / Standard of the Faculty (Overall)






